TOWNSHIP COUNCIL MEETING

May 9, 2016

The Meeting of the Township Council of the Township of Vernon was convened at 7:30 p.m. on Monday, May 9, 2016 in the Vernon Municipal Center, 21 Church Street, Vernon, New Jersey with Council President Dan Kadish presiding.

STATEMENT OF COMPLIANCE

Adequate notice of this meeting had been provided to the public and the press on January 5, 2016, and was posted on the bulletin board in the Municipal Building in accordance with the Open Public Meetings Act, N.J.S.A. 10:4-7.

ROLL CALL OF MEMBERS

Present were Council Members Jean Murphy, Sandra Ooms, Patrick Rizzuto, Dick Wetzel and Council President Dan Kadish. Also present were Mayor Harry Shortway, Administrator Charles Voelker and Township Attorney John Ursin.

EXECUTIVE SESSION

Council President Kadish read the following resolution for Executive Session.

WHEREAS, the Open Public Meetings Act, N.J.S.A. 10:4-6 permits the exclusion of the public in certain circumstances; and

WHEREAS, this public body is of the opinion that such circumstances presently exist;

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Vernon as follows:

- 1. The public shall be excluded from discussion of and action upon the hereinafter specified subject matter.
- 2. The general nature of the subject matters to be discussed are: {(N.J.S.A. 10:4-12b (7)}: Contract Negotiations: Property Acquisition (Anticipated Time of Disclosure October 2016).
- 3. This resolution shall take effect immediately.

Council President Kadish asked for a motion to enter into executive session:

The Council adjourned into executive session at 6:33 p.m..

Council President Kadish asked for a motion to adjourn the executive session at 6:56 pm and return to open session at 7:30 p.m.:

The Council returned to open session at 7:30 p.m..

STATEMENT OF COMPLIANCE

Adequate notice of this meeting had been provided to the public and the press on January 5, 2016, and was posted on the bulletin board in the Municipal Building in accordance with the Open Public Meetings Act, N.J.S.A. 10:4-7.

ROLL CALL OF MEMBERS

Present were Council Members Jean Murphy, Sandra Ooms, Patrick Rizzuto, Dick Wetzel and Council President Dan Kadish. Also present were Mayor Harry Shortway, Administrator Charles Voelker and Township Attorney John Ursin.

SALUTE TO THE FLAG

Council President Kadish led the assemblage in the salute to the flag.

ITEMS FOR DISCUSSION:

Parking Meadowlark and Carol Drive

Chief Randy Mills, stated that the issue with parking for the Appalachian Trail has increased dramatically particularly because the boardwalk in Vernon has been featured on several websites which has brought increased traffic to the area. Chief Mills indicated that in 2015 there were 156 calls and 169 tickets issued for parking infractions in the area of the trail. In 2016, year to date, there were 184 calls and 148 tickets issued. Chief Mills indicated the Township did not wish to issue summonses but would prefer to make it clear where were parking was available. Chief Mills stated that the ordinance protects the south side of Carol Drive even though there are no homes in that area. Chief Mills indicated he was posting an officer at the location on the weekends. Chief Mills discussed adding parking to other locations and indicated that the Township is working with the County, State and Appalachian trail staff to work towards solutions.

Audrey Colby, stated she wanted people to come to town and visit but it is difficult with the parking situation for her to have family and friends visit. Ms. Colby indicated that she has to plan ahead because otherwise her guests have nowhere to park. Ms. Colby indicated that people throw garbage on her lawn and park in front of her driveway blocking her exit.

Council President Kadish discussed that the Township would be meeting with the various government entities to try and come up with a viable solution to this problem. Council President Kadish indicated that everyone was enthusiastic about addressing the problem.

Teresa Vhiti, indicated that she too is having issues with people throwing garbage in front of her home as well as urinating on the lawn. Ms. Vhiti asked if signs can be placed in front of her home. Ms. Vhiti indicated that her mailbox is regularly blocked so she is unable to get mail and she has come out to children playing in her driveway.

Chris Bruden, indicated that he policed the area regularly and cleaned up the walk ways as well as put out a 5 gallon garbage pail. Mr. Bruden suggested asking some of the websites to take down the advertising.

Chief Mills indicated he was looking forward to the meeting and finding solutions for this problem. Chief Mills noted extra officers will be working the area.

Michele Brove stated she lived on _____. Ms. Brove suggested posting something positive on Facebook. Ms. Brove suggested residents only parking. Chief Mills expressed concern over limiting access to public roads.

Bill Perkins, stated he opposed the township purchasing the corner house on Carol which was in foreclosure to make it into a parking lot.

Jessi Paladini stated that many years ago parking lots were promised. Chief Mills indicated at that time property was available for a lot but local residents were opposed to it. Discussion ensued that the money for that project was no longer available from the federal government.

Heather Miller on _____ commended the police department for listening to every complaint. Ms. Miller stated that she is concerned about having her children play outside. Ms. Miller expressed concern about people making U-turns in her driveway. Chief Mills indicated it was acceptable for her to put cones across her driveway and to leave her car there.

Bill Perkins stated these are quality of life issues which did not seem fair for the residents to have to deal with.

Marie Capazone, stated the neighboring streets were also filled with cars. Ms. Capazone supported a parking lot being built. Council President Kadish suggested if a lot was built to indicate when the lot was full like other places did and encourage people to come back at a later date.

PUBLIC COMMENT:

Council President Kadish asked for a motion to open the meeting for Public Comments.

MOTION: Jean Murphy SECOND: Sandra Ooms All members were in favor.

Ed Snook, Chairman of the MUA, sated the MUA needs a resolution to go to the DEP to study the whole map. Council President Kadish indicated the Council was looking for a cost feasibility study for the project. Mr. Snook indicated that the MUA would like to get the map approved and then once that is done they will do a study. Council Member Rizzuto indicated that he did not believe the MUA needed approval from the Council to do a study. Mr. Snook stated to do a study of the entire map would be very costly. Council President Kadish expressed concerns of approving a map without know if it was cost effective.

Jim Nunemaker, questioned when was Lake Wallkill Road going to be repaved. Mr. Nunemaker indicated that people were driving down the middle of the road to avoid the potholes. Mr. Nunemaker stated this was a safety issue particularly because of the large trucks on the road. Mr. Nunemaker indicated New York had paved their portions of the road and he wanted to see the last section completed.

Gary Martinsen expressed concern over the large amount of Sherriff's sales in the newspaper on Sunday.

CLOSED TO PUBLIC COMMENTS

Seeing no more members of the public wishing to speak, Council President Kadish asked for a motion to close the public portion of the meeting.

PRESENTATIONS

Historic Scenic By-way

Historic Society President Jessica Paladini came forward.

Ms. Paladini explained that the Western Highlands Scenic By-way was originally approved by the Vernon Township Council in 2010 and originally planned for Route 23 and Route 94 to the state line making an extended loop. It was extending to Vernon Crossing Road and Sandhill and was declared the 8th official by-way on July 29, 2014. Ms. Paladini stated the by-way began as the brainchild of Dennis Miranda, Carol Gunn Kadish and herself. Ms. Paladini indicated that in 2013, the Historic Society had made maps of the by-way. Ms. Paladini stated the Historic Society was going to have a photo contest for the scenic byway. Ms. Paladini stated the New Jersey Department of Transportation will provide funding. Ms. Paladini stated the by-plan, like a master plan, will be made by the Vernon Historic Society and certified by the Board. Ms. Paladini stated the logo was designed by Eva Bonna. Ms. Paladini indicated signs would be marked all along the route and Ms. Cindi Bloom was the state representative.

MAYOR'S REPORT

- Mayor Shortway stated that he would like to have Sammis Road and Lake Wallkill Road paved this summer.
- Mayor Shortway stated he needs to meet with various different prospective businesses that need water and sewers. Mayor Shortway stated there is potential restaurant also coming, indicating he would like to see ratables and jobs.

- Mayor Shortway indicated he had met with Chief Mills to discuss the overcrowded parking situation and they are working on both short and long term solutions. Mayor Shortway stated the new hikers on the trail want to hike the trail during the day and then arrive in a town to stay in a hotel along the way. Mayor Shortway indicated that he would like to make a new trail head and connect a boardwalk to the existing boardwalk and add parking in the that location.
- Mayor Shortway noted that Legends has a number of outstanding tax liens and that there is large amount owed. Mayor Shortway noted that the State Fire Marshal, township fire marshal and zoning have been looking at the property as people appear to be living their long term.
- Mayor Shortway indicated that Taste of Vernon is an outstanding success.

Box 941, Vernon, NJ 07462 for the demolition of the unsafe dwelling located on Route 565, Vernon NJ for an amount not to exceed \$8400.00.

WHEREAS, First Hartford Realty Corporation, 149 Colonial Road, Manchester, Connecticut, posted Performance Bond 012023930 in the amount of \$1,207,829.20 to guarantee proper construction and installation of certain improvements associated with the construction of the CVS Pharmacy located at Route 94 and Main Street, Block 144.01, Lots 1, 2, 3, and 4 ("Property") in the Township of Vernon ("Township"), Sussex County, New Jersey; and

WHEREAS, following final construction and installation of improvements, the Township Engineer conducted a site inspection of the Property and determined that said improvements were completed in accordance with the performance guarantee and are satisfactory; and

WHEREAS, in accordance to <u>N.J.S.A.</u> 40:55D-53, a resolution authorizing release of the Performance Bond is required by the Township Council; and

WHEREAS, based upon the foregoing, the Township Engineer recommends release of Performance Bond 012023930 in the full amount of \$1,207,829.20; and

WHEREAS, as a condition of release, the Township Engineer further recommends that the Township accept Maintenance Bond SU30398 in the amount of \$21,195.00 to assure proper post-construction maintenance as required by Chapter 330 of the Township Code entitled "Land Development."

NOW BE IT RESOLVED, by the Mayor and Township Council of the Township of Vernon, in the County of Sussex and State of New Jersey as follows:

RESOLUTION ACCEPTING A NON-EXCLUSIVE, PERPETUAL ACCESS AND MAINTENANCE EASEMENT OVER A PORTION OF BLOCK 144.01, LOT 1 IN THE TOWNSHIP OF VERNON RELATED TO A CERTAIN LIGHT POLE CONSTRUCTED AS PART OF THE CVS PHARMACY DEVELOPMENT

WHEREAS, First Hartford Realty Corporation ("Developer") previously received Major Site Plan and Major Subdivision approval along with Ancillary Variance Relief and Exceptions from the Vernon Township Land Use Board ("Board") to construct a CVS Pharmacy and associated parking on property designated as Block 144.01, Lots 1, 2, 3 and 4 on the Official Tax Maps for the Township of Vernon ("Township") more commonly known as Route 94 and Main Street; and

WHEREAS, the approved development, among other things, provided for the construction of a light pole and associated appurtenances in the plaza area located in the northwest corner of Block 144.01, Lot 1 at the intersection of Route 94 (also known as McAfee Vernon Road) and Main Street (collectively, the "Plaza Area"); and

WHEREAS, the Developer desires to grant the Township a non-exclusive, perpetual access and maintenance easement over the portion of the Plaza Area on Lot 1 as depicted on the Major Subdivision Plat for CVS Health Corporation, #302, 304, 306 & 310 Route 94, Block 144.01, Lots 1, 2, 3 & 4, Vernon Township, Sussex County, New Jersey prepared by Blue Marsh Associates, Inc. Land Surveyors and Planners dated October 17, 2014, last revised April 1, 2015 and recorded in the Sussex County Clerk's Office on June 22, 2015 as Map 1477, to permit the location, access and maintenance of the light pole described therein; and

WHEREAS, the Township desires to assume responsibility for the maintenance and repair of the light pole and the easement area as described more particularly in the Deed of Easement attached hereto as **Exhibit A**; and

WHEREAS, the Board attorney and Township Engineer determined that the Deed of Easement is acceptable and recommend that same be signed and returned to the Developer for filing; and

NOW BE IT RESOLVED, by the Mayor and Township Council of the Township of Vernon, in the County of Sussex and State of New Jersey as follows:

- 1. The Township hereby accepts the non-exclusive and perpetual easement for access and maintenance over the portion of the Plaza Area on Lot 1 specified within the metes and bounds descriptions described in the attached Deed of Easement between the Developer and the Township.
- 2. The Mayor is authorized and directed to execute the attached Deed of Easement, and the Municipal Clerk, is authorized and directed to attest to any and all documents, and to perform all actions, which may be necessary in order to effectuate the intentions of this Resolution.

RESOLUTION #16-130

AUTHORIZING PROFESSIONAL SERVICE CONTRACT WITH LIFELOCK, INC. FOR RENEWAL OF IDENTITY THEFT PROTECTION FOR ELIGIBLE MUNICIPAL EMPLOYEES

WHEREAS, there exists a need of a Professional Service Contract for the Township of Vernon for the renewal of Identity Theft Protection for previously registered Municipal Employees; and

Council Member Murphy indicated in relation to the tree grant that when Resolution 13-223 was voted on by the Council, the original document included a payment of \$300 for the grant writer. At the April 11, 2016 Council meeting, the copy received by the Council now said \$6,000: \$3,000 for the grant writer and \$3,000 more over the four phases.
