TOWNSHIP COUNCIL MEETING

JULY 27, 2015

The Meeting of the Township Council of the Township of Vernon was convened at 7:30 p.m. on Monday, July 27, 2015 in the Vernon Municipal Center, 21 Church Street, Vernon, New Jersey with Council President Patrick Rizzuto presiding.

STATEMENT OF COMPLIANCE

Adequate notice of this meeting had been provided to the public and the press on January 4, 2015, and was posted on the bulletin board in the Municipal Building in accordance with the Open Public Meetings Act, N.J.S.A. 10:4-7.

ROLL CALL OF MEMBERS

Present were Council Members Dan Kadish, Brian Lynch, Jean Murphy, Dick Wetzel and Council President Patrick Rizzuto. Also present were Mayor Victor Marotta, Administrator Bill Zuckerman and Township Attorney John Ursin.

SALUTE TO THE FLAG

Council President Rizzuto led the assemblage in the salute to the flag.

MOMENT OF SILENCE Council President Rizzuto asked for a moment of silence in memoriam of the 5 fallen soldiers killed in Chattanooga, TN as well as the victims of Lafayette, LA movie theater shooting.

PUBLIC COMMENT:

Council President Rizzuto asked for a motion to open the meeting for Public Comments.

MOTION: Brian Lynch SECOND: Jean Murphy All members were in favor.

Gary Martinsen, Vernon stated that the fireworks from the Highland Lakes Fire Department were wonderful. Mr. Martinsen said the fireworks rivaled Macy's and there was no need to leave town to see fireworks.

CLOSED TO PUBLIC COMMENTS

Seeing no more members of the public wishing to speak, Council President Rizzuto asked for a motion to close the public portion of the meeting.

MOTION: Jean Murphy SECOND: Dan Kadish All Members were in favor.

MAYOR'S REPORT

- Mayor Marotta announced Tom Pinand, head of the Building Department, has retired after 19 years. Mayor Marotta explained that the Township had appointed David Condon, a current Township Inspector, in the interim and the Township was advertising this position.
- o Mayor Marotta discussed that the issues with the Building Department computer program had been rectified but there were some problems with old files.
- Mayor Marotta also announced that the Township had received notification of the retirement of Tax Collector Antoinette Izzo, who was retiring after 20 years. Mayor Marotta indicated the Township was advertising for a replacement.
- Mayor Marotta remarked on the beautiful job of landscaping and laying pavers around the Bear Samantha, in front of the municipal building which was completed by Boy Scout Ryan Williams

- and his troop. Mayor Marotta explained that Scout Williams is a candidate for Eagle Scout, a graduate of Vernon High School and attending NJIT in the fall.
- Mayor Marotta noted that earlier this year the Council had requested an analysis on the costs associated with returning the Health Department to Vernon. Mayor Marotta indicated that Administrator Zuckerman would be providing that report.
- Administrator Zuckerman indicated that he and CFO Yetter had investigated the costs and met with the County Health Department. Administrator Zuckerman discussed the services the County would keep and what the Township would be responsible for if the Township took over the Health Department. Administrator Zuckerman noted that in 2008 the Township was spending \$420,000 per year to maintain the Health Department on site. Zuckerman explained that the current contract with the County was \$404,000. Administrator Zuckerman explained if the Township were to take over the Health Department in 2016 that the estimated cost would be \$653,000 just taking over the services. Administrator Zuckerman discussed the Township would need to take on some new staff and health benefits as well as furniture and cars. Administrator Zuckerman recommended that the Township keep the contract with Sussex County. Administrator Zuckerman discussed the Township adding an in house liaison between the Township and Health department that would have access to the County Health Department computer systems and could review same. Administrator Zuckerman explained they did not determined who would be serving as the liaison. Council Member Murphy noted that when the Health Department was here, one of the tools provided was the septic reports which most Realtors obtain. Council Member Murphy stated that information is on line so you no longer have to wait. Council Member Lynch stated getting information from the County Health Department has been frustrating. Administrator Zuckerman discussed that this liaison would hopefully alleviate this problem. Council Member Wetzel stated he was satisfied with these results.
- Mayor Marotta discussed that in 2014 the Township had implemented collecting fines in the municipal court via credit card. Mayor Marotta explained in the first six months of implementing this plan the township had collected \$32,000 which has surpassed all fines collected in 2014. Mayor Marotta explained the township had a private collection company for old debt where a certain percentage goes to the collection company and the remainder comes to the Township. Mayor Marotta indicated approximately \$3,000 had been collected through their efforts. Mayor Marotta thanked Court Clerk Donna Zuidema, Lindsay Miller and Judge Devine for their efforts. Council Member Murphy indicated she had received an article today about Zombie Foreclosures. Council Member Murphy discussed the issue with septic systems based on the increased regulation by the State enforced through the Health Department. Council Member Murphy stated this increased regulation is forcing people out of their homes because persons are unable to make the repairs and people simply walk away from their homes. Council Member Murphy stated that the Board of Realtors was looking into this matter and compiling costs. Mayor Marotta indicated that in 2012 when the State changed the regulations he had brought this issue to the Council's attention specifically because Herb Yardley of the Board of Health had predicted that people would walk away from homes rather than make repairs. Mayor Marotta stated he believed this issue required legislative changes to address it but it is significant. Mayor Marotta further indicated that in some areas of town that better than 50% of the septics were failing.

AUTHORIZING PROFESSIONAL SERVICES CONTRACT WITH VITAL COMMUNICATIONS, INC. IN THE AMOUNT NOT TO EXCEED \$15,600.00

WHEREAS, there exists a need for professional services for the Township of Vernon for the purpose of Computer software and services for Tax Assessment/CAMA, Tax Collection and Internet Access including tax billing and customer support; and

WHEREAS, the Township has determined that Vital Communications, Inc., the Township's current contractor providing these services, is qualified to continue providing the Township with such services; and

WHEREAS, the Chief Financial Officer has certified that funds are available for this purpose subject to the adoption of the 2016 Municipal Budget; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1, et seq.) requires that the resolution authorizing these "Professional Services" without competitive bids must be publicly advertised; and

WHEREAS, Vernon desires to appoint Vital Communications, Inc., pursuant to a contract under the provisions of N.J.S.A. 19:44A-20.4 and/or N.J.S.A. 19:44A-20.5; and

WHEREAS, the Chief Financial Officer has certified that the value of the contract will not exceed \$17,500.00; and

WHEREAS, the term of the contract will be from July 1, 2015 to June 30, 2016, with a total contract price not to exceed \$15,600.00; and

NOW THEREFORE BE IT RESOLVED, by the Township Council of the Township of Vernon, County of Sussex and State of New Jersey as follows:

- 1. The Township of Vernon is authorized to engage Vital Communications, Inc., for the purpose of Computer Services for Tax Assessment/CAMA, Tax Collection and Internet Access; and
- 2. The Mayor and Township Clerk are hereby authorized and directed to execute a Professional Services Contract with Vital Communications, Inc., in an amount not to exceed \$15,600.00.

This Professional Services Contract is awarded without competitive bidding (1) as a "Professional Service" under the provisions of the Local Public Contracts Law and/or (2) for the provision or performance of goods or services for the support or maintenance of proprietary computer hardware and software.

A copy of this Resolution shall be published in the New Jersey Herald by the Township Clerk as required by law within ten (10) days of its passage and a true copy of same and the Professional Services Contract shall be available for inspection in the office of the Township Clerk.

CHAPTER 159 RESOLUTION REQUESTING APPROVAL OF REVENUE AND APPROPRIATION AMENDING THE 2015 BUDGET AS A REVENUE AND APPROPRIATION OF \$140,000.00

WHEREAS, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

WHEREAS, said Director may also approve the insertion of an item of appropriation for an equal amount; and

WHEREAS, the Township has entered into an agreement with the Vernon Township Municipal Utility Authority for \$140,000.00 for the purchase of a sewer easement from the New York Susquehanna and Western Railway Corporation; and wishes to amend its 2015 budget for this amount as a revenue.

NOW, THEREFORE, BE IT RESOLVED that the Township Council of the Township of Vernon hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget of the year 2015 in the sum of \$140,000.00 which is now available as a revenue from the Vernon Township Municipal Utility Authority;

BE IT FURTHER RESOLVED that a like sum of \$140,000.00 is hereby appropriated under the caption Purchase of Sewer Easement.

COUNCIL COMMENTS

Council Member Wetzel stated he had no comments.

Council Member Lynch stated he had no comments.

Council Member Kadish indicated there would be a festival called Elemental Fusion from September 10-13 at the Rickey Farm. Council Member Kadish stated there would be 75 bands and 4 stages. Council Member Kadish wished Mr. Rickey much success with his event but expressed concern if there was an emergency with such a large number of people. Mayor Marotta indicated the taxes had been paid and the Township had received an application. Mayor Marotta noted he was already in discussion about same with the Chief of Police and Fire Marshal and would reach out to the Ambulance Squads. Council Member Wetzel also expressed concern, noting that he had gone to Cooperstown where there were 60,000 people at the baseball hall of fame; he indicated emergency plans were needed.

Council Member Murphy commented that on Route 515 in front of the Faline Building there was a "Shop Vernon" sign. Council Member Murphy indicated the windows of the building were broken and suggested moving the sign to a better location. Council Member Murphy indicated that at the last meeting she had discussed the salary ranges and that a resolution was not passed for 2014 and the Township Attorney was to look into same. Attorney Ursin stated he was not aware of what occurred in 2014 and unless directed by the Council he had not investigated 2014. Council Member Murphy stated that Attorney Ursin had indicated that for an increase a resolution should have been passed. Council

Member Murphy stated that last year a resolution was not passed and expressed concern that this was procedurally deficient. Mayor Marotta stated the action taken in 2014, 2013, and 2012 was done on advice of Counsel. Mayor Marotta stated advice is given by the attorney and in some cases those attorney opinions need to be clarified by a judge. However, Mayor Marotta continued, nothing was done without the advice of Counsel. Council Member Murphy expressed concern that the law changed from year to year depending on who was the attorney. Township Attorney Ursin stated he had not reviewed the procedural history for 2014, if the Council would like him to make an inquiry he would do so. Council Member Murphy reiterated that items should not be handled differently because there is a different attorney. Council Member Murphy noted that the increase in 2014 given to the Township Administrator was not in the budget when it was passed. Council Member Murphy indicated that when it was said that the Council approved things; she begged to differ.

Council President Rizzuto had no comments.

There being no further items of business to be conducted on the agenda, a motion for Adjournment was made by Council Member Lynch, seconded by Council Member Wetzel with all members voting in favor.
