TOWNSHIP COUNCIL REGULAR MEETING

DECEMBER 8, 2014

The Regular Meeting of the Township Council of the Township of Vernon was convened at 7:30 p.m. on Monday, December 8, 2014 in the Vernon Municipal Center, 21 Church Street, Vernon, New Jersey with Council President Brian Lynch presiding.

STATEMENT OF COMPLIANCE

Adequate notice of this meeting had been provided to the public and the press on January 8, 2014, and was posted on the bulletin board in the Municipal Building in accordance with the Open Public Meetings Act, N.J.S.A. 10:4-7.

ROLL CALL OF MEMBERS

Present were Council Members Dan Kadish, Jean Murphy, Patrick Rizzuto, Dick Wetzel and Council President Brian Lynch. Also present were Township Administrator Bill Zuckerman, CFO Elke Yetter, Mayor Victor Marotta and Township Attorney Kevin Kelly.

There was no Executive Session.

SALUTE TO THE FLAG

Council President Lynch led the assemblage in the salute to the flag.

MOMENT OF SILENCE

Council President Lynch asked for a moment of silence noting it had been 73 years since Pearl Harbor.

PROCLAMATIONS

Council President Lynch asked Mayor Marotta and the members of the Vernon Ambulance Squad to come to the podium for the following proclamation:

WHEREAS, for five decades the selfless volunteers of Vernon Township Ambulance squad, both past and present, have worked diligently with tireless dedication and without regard to the hours, geographic challenges, road conditions during inclement weather, especially during the winter months, to ensure the well being of residents of Vernon Township; and

WHEREAS, an impressive record of training in the use of state-of-the-art equipment, as well as knowledge of the most current techniques in providing emergency care and prolonging life, attests to the concerns and compassion of the members of the Vernon Township Ambulance Squad and to their devotion to serving their community; and

WHEREAS, the volunteers of the Vernon Township Ambulance Squad remain always ready to save lives, lessen injuries, ease pain and to provide comfort; and

WHEREAS, the strength and success of the Township of Vernon and vitality of our community depend in great measure upon selfless volunteer organizations and individuals, exemplified by the Vernon Township Ambulance Squad and its members, who have proven themselves to be models of excellence in duty and performance; and

WHEREAS, Vernon Township thanks the Vernon Township Ambulance Squad for their exemplary service.

Council President Lynch and Mayor Marotta both thanked the members of the Vernon Township Ambulance Squad for their years of service.

PUBLIC COMMENT: Council President Lynch asked for a motion to open the meeting for Public Comments.

MOTION:Dan KadishSECOND:Pat RizzutoAll members were in favor.

Gary Martinsen thanked the Council for honoring the Vernon First Aid Squad and for putting the holiday decorations up early. Mr. Martinsen commented that with the weather for tomorrow the Township may need to cancel the tree lighting event and asked that it be posted on the web-site. Mr. Martinsen wished everyone a Happy Chanukah and Good Yule.

Sally Rinker, Vernon, provided to the Council an unsigned letter that she stated was written by Mayor Marotta about Camp Sussex. Ms. Rinker stated she had written a letter to the editor about the purchase of Camp Sussex. Ms. Rinker commented that she took exception to comments that she stated were made about her by the Environmental Commission Chair. Ms. Rinker stated that she believed the Environmental Commission's meeting in April was a violation of the open public meetings act. Ms. Rinker opined that there was a conspiracy to dupe the public about that meeting. Ms. Rinker discussed comments that were made at that meeting. Ms. Rinker noted that a recording of the meeting had been posted on the Vernon Tax Payer Association's web-site.

Christa Geary, Highland Lake, stated that Christmas is a time of peace. Ms. Geary discussed that she was committed to doing the right thing and standing by the courage of her convictions. Ms. Geary pointed out that civility is important. Ms. Geary noted that if you lose but you run a fair and honest race you win. Ms. Geary stated the message of Christmas is the miracle of hope.

Mr. Geary commented that jumping at each other is not the Christian thing to do. Mr. Geary opined that nobody takes "Shop Vernon." Mr. Geary further opined that town center is a joke. Mr. Geary stated the township did not need more parks and questioned where the senior housing was that was promised to be built.

Beverly Budz, Chairperson of the Environmental Commission commented on the previous comments of Ms. Rinker. Ms. Budz stated she was repulsed by persons who call themselves Christians but then sit in judgment of everybody else.

Robert Oliver, stated he had not made up his mind about purchasing Camp Sussex and needed more facts. Mr. Oliver opined that comments made by the Environmental Commission Chair were truthful.

CLOSED TO PUBLIC COMMENTS

Seeing no more members of the public wishing to speak, Council President Lynch asked for a motion to close the public portion of the meeting.

TOWNSHIP MAYOR'S REPORT

- Mayor Marotta stated that on Thursday United Water will be pressure testing the lines in town center as they are purchasing some but not all of them. Mayor Marotta noted United Water is still waiting on BPU approval. Mayor Marotta indicated that CVS's application was to be heard on Wednesday in front of the planning board and will be the first new building in quite some time.
- Mayor Marotta indicated that 20 merchants are now participating in the "Shop Vernon" program which had generated \$200,000 in sales and \$14,000 worth of tax reductions.

Mayor Marotta pointed out that 1000 families had registered with the program and that it had caused our EDAC to work together with local Vernon businesses.

- Mayor Marotta noted that the Township had made their application for a senior housing project but they were still waiting on COAH approval. Mayor Marotta stated that if the housing were to be built now, it would not be subsidized as the Township is waiting for approval. Mayor Marotta stated that the fact the Township had not received approval was not for a lack of trying.
- Mayor Marotta advised that the first snow storm of the season had been taxing, but it was not because of lack of preparedness. Mayor Marotta explained that there were a number of accidents and trees that had fallen which took road crews away from plowing and salting as they worked to clear the roads. Mayor Marotta stated that every piece of equipment now had GPS so that the Township could track them all. Mayor Marotta also noted that the salt sheds were completely stocked at this time. Council President Lynch noted that last year the NJ DOT had gotten contracts and reserves on much of the salt for the roads in preparation of the Super Bowl that was hosted in New Jersey. Mayor Marotta explained that the Township also stores salt at the various private communities as it has proven to be less expensive to purchase it outright than reimburse the communities later under the provisions of the Kelly Bill. Mayor Marotta also explained that it reduced travel time as the plows did not have to drive all the way back to town hall to obtain salt to get back on the road.

AWARDING A CONTRACT TO KRAFT POWER CORPORATION TO PROVIDE SEMI-ANNUAL MAINTENANCE SERVICE FOR TOWNSHIP-OWNED GENERATORS

WHEREAS, the Township of Vernon has a need to maintain its emergency generators; and

WHEREAS, after a review of quotes and consultation of Award of Contract to another vendor under MCCPC, Contract #46, Kraft Power Corporation supplied the most cost-effective quotation to provide these services at \$5100.00; and

WHEREAS, the Qualified Purchasing Agent recommends that the Township award a contract for this service to Kraft Power Corporation; and

WHEREAS, the contract term is from December 1, 2014 through November 30, 2015; and

WHEREAS, the Chief Financial Officer has certified that funds are available in 10577237.

NOW THEREFORE BE IT FURTHER RESOLVED, by the Township Council of the Township of Vernon, County of Sussex and State of New Jersey, the Mayor is authorized to execute a contract with Kraft Power Corporation, 241 West Parkway, Pompton Plains, NJ 07444, to provide semi-annual maintenance service to the Township-owned emergency generators.

WHEREAS, on September 22, 2014, by way of adoption of Resolution #14-156, the Council of the Township of Vernon awarded a contract to Tilcon New York, Inc. for Road Resurfacing on Upper Plateau and Murphy Court which contract provided for an expenditure of \$89,356.00; and

WHEREAS, in a memo dated November 17, 2014, the Township Engineer states that said contract has been completed and recommends the project be accepted as final and complete; and

WHEREAS, in processing the final paperwork for the project, costs for asphalt were reduced requiring Change Order #1, which reflects an adjustment of the amount of the original contract of \$89,356.00 by the subtraction of two items totaling \$7,656.20, resulting in an adjusted contract amount of \$81,699.80.

WHEREAS, the Township Engineer, in concurrence with the Mayor, recommends approving Change Order No. 1 which will decrease the total contract amount by \$7,656.20 to a total contract amount of \$81,699.80.

RESOLUTION #14-198

ESTABLISHING A PERFORMANCE AWARDS PROGRAM AND APPOINTING A PUBLIC EMPLOYEES' AWARDS COMMITTEE FOR THE TOWNSHIP

WHEREAS, <u>N.J.S.A.</u> 40A:5-31 provides that municipalities may establish and maintain plans for award programs for employees, designed to promote efficiency and economy in government functions, and to reward individual employees for meritorious performances and suggestions; and

WHEREAS, municipalities have power and authority to make appropriations of money, establish and make awards in the form of cash, medals, citation certificates, insignia, or other appropriate devices to employees selected as recipients of awards in accordance with programs established pursuant to this Statute; and

WHEREAS, the Statute requires the establishment and appointment of 5 persons to be known as the "Public Employees' Awards Committee".

NOW, THEREFORE, BE IT RESOLVED by the Council of the Township of Vernon that a "Public Employees' Awards Committee" is hereby established.

BE IT FURTHER RESOLVED that the Public Employees' Awards Committee shall consist of the Mayor, Chief Financial Officer, Business Administrator, and 2 Members of the Governing Body of which 2 shall be appointed for terms of 3 years, 2 for 2 years, and 1 for 1 year and thereafter appointments shall be made for terms of 3 years.
