TOWNSHIP COUNCIL REGULAR MEETING

DECEMBER 22, 2014

The Regular Meeting of the Township Council of the Township of Vernon was convened at 7:30 p.m. on Monday, December 22, 2014 in the Vernon Municipal Center, 21 Church Street, Vernon, New Jersey with Council President Brian Lynch presiding.

STATEMENT OF COMPLIANCE

Adequate notice of this meeting had been provided to the public and the press on January 8, 2014, and was posted on the bulletin board in the Municipal Building in accordance with the Open Public Meetings Act, N.J.S.A. 10:4-7.

ROLL CALL OF MEMBERS

Present were Council Members Dan Kadish, Patrick Rizzuto, Dick Wetzel and Council President Brian Lynch. Council Member Jean Murphy appeared via phone. Also present were Mayor Victor Marotta and Township Attorney Kevin Kelly.

There was no Executive Session.

SALUTE TO THE FLAG

Council President Lynch led the assemblage in the salute to the flag.

MOMENT OF SILENCE

Council President Lynch asked for a Moment of Silence in Honor of Police Officers Ramos and Liu who assassinated earlier this week in New York City.

PUBLIC COMMENT: Council President Lynch asked for a motion to open the meeting for Public Comments.

MOTION: Dan Kadish SECOND: Pat Rizzuto All members were in favor.

Beverly Budz, Chairperson of the Environmental Commission reminded residents that New Jersey has a three minutes idling law which was revised recently. Ms. Budz stated it was the mission of the Environmental Commission to watch over the town's air, land and water. Ms. Budz stated the commission is bringing attention to this law because as a resort town there are a lot of out of state visitors. Ms. Budz stated extensive idling is against the law; let's not forget to be kind to mother earth.

Teresa Vihti, Glenwood, stated the fireworks and tree lighting were awesome. Ms Vihti stated there were many people in attendance. Ms. Vihti wished everyone a Merry Christmas.

Sandra Ooms, stated that 2 years ago the Council voted to have a Community Garden. Ms. Ooms explained that trees were supposed to be planted to block the view for the neighboring streets. Ms. Ooms expounded that the trees planted were not sufficient and some of the money from the grant received by the environmental commission could be used to rectify the situation. Ms. Ooms also stated that the gate is never locked and the garden is in a poor state. Ms. Ooms asked how could the Township take care of an 87 acres for Camp Sussex when it could not take care of the garden.

CLOSED TO PUBLIC COMMENTS

Seeing no more members of the public wishing to speak, Council President Lynch asked for a motion to close the public portion of the meeting.

TOWNSHIP MAYOR'S REPORT

o Mayor Marotta stated that eleven (11) trees were planted for the Community Garden and spaced based on the recommendation of the garden professional. Mayor Marotta explained that the Township had not yet received the second no net loss grant. Council Member Kadish questioned if the Township had gotten paid. Mayor Marotta explained that the Township received \$33,000 for the first grant; not the \$348,000 for the second grant. Mayor Marotta further explained the Township had been awarded the grant but it had not been received at this juncture. Council

Member Kadish asked what type of tree had been planted near the garden. Mayor Marotta explained it was an evergreen as recommended by the garden expert.

RESOLUTION #14-201

CHAPTER 159 RESOLUTION REQUESTING APPROVAL OF REVENUE AND APPROPRIATION AMENDING THE 2014 BUDGET AS A REVENUE AND APPROPRIATION OF \$7,500.00

WHEREAS, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

WHEREAS, said Director may also approve the insertion of an item of appropriation for an equal amount; and

WHEREAS, the Township has been awarded a \$7,500.00 2014 Drive Sober or Get Pulled Over Statewide Year End Holiday Crackdown from the New Jersey Division of Highway Traffic Safety; and wishes to amend its 2014 budget for this amount as a revenue.

NOW, THEREFORE, BE IT RESOLVED that the Township Council of the Township of Vernon hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget of the year 2014 in the sum of \$7,500.00 which is now available as a revenue from the New Jersey Division of Highway Traffic Safety,

RESOLUTION TO JOIN (RENEW) THE STATEWIDE INSURANCE FUND

WHEREAS, a number of local units have joined together to form the Statewide Insurance Fund ("FUND"), a joint insurance fund, as permitted by N.J.S.A. 40A:10-36, *et seq.*; and

WHEREAS, the Township of Vernon ("LOCAL UNIT") has complied with relevant law with regard to the acquisition of insurance; and

WHEREAS, the statutes and regulations governing the creation and operation of joint insurance funds contain elaborate restrictions and safeguards concerning the safe and efficient administration of such funds; and

WHEREAS, the LOCAL UNIT has determined that membership in the FUND is in the best interest of the LOCAL UNIT; and

WHEREAS, the LOCAL UNIT agrees to be a member of the FUND for a period of three (3) years, effective from **January 1, 2015** terminating on **January 1, 2018** at 12:01 a.m. standard time; and

WHEREAS, the LOCAL UNIT has never defaulted on claims, if self-insured, and has not been canceled for non-payment of insurance premiums for two (2) years prior to the date of this Resolution.

NOW, THEREFORE, BE IT RESOLVED that the LOCAL UNIT does hereby agree to join the Statewide Insurance Fund; and

BE IT FURTHER RESOLVED that to the extent required by law, the Local Unit shall provide notice of the Indemnity and Trust Agreement to the Office of the State Comptroller; and

BE IT FURTHER RESOLVED that the LOCAL UNIT will be afforded the following coverage(s) as marked "Yes":

RESOLUTION APPOINTING FUND COMMISSIONER

WHEREAS, the Township of Vernon (hereinafter "Local Unit") is a member of the Statewide Insurance Fund (hereinafter "Fund"), a joint insurance fund as defined in N.J.S.A. 40A:10-36 *et seq.*; and

WHEREAS, the Fund's Bylaws require participating members to appoint a Fund Commissioner.

NOW, THEREFORE, BE IT RESOLVED by the governing body of the Township of Vernon that William Zuckerman is hereby appointed as the Fund Commissioner for the Local Unit for the calendar year 2015; and

BE IT FURTHER RESOLVED that Elke Yetter is hereby appointed as the Alternate Fund Commissioner for the Local Unit for the calendar year 2015; and

BE IT FURTHER RESOLVED that the Local Unit's Fund Commissioner is authorized and directed to execute all such documents as required by the Fund.

Council Member Kadish questioned the dollar amount and amount of years this application applied to. Mayor Marotta explained that resolution was for the Township to seek \$60,000 to offset the cost of salaries of officer's working in the Township's schools. Council Member Kadish asked if the Township had made the 1991 bench-mark. Mayor Marotta indicated that we had and the application was done by the police department. Council Member Kadish questioned that if accepting the grant meant that the Township could not terminate officers. Mayor Marotta indicated anyone could be terminated for cause. Council Member Kadish questioned what the grant money would be used for. Mayor Marotta indicated it was simply for the salary of the officer.

Council Member Kadish questioned why the Township was renewing the Risk Management Consultant at this time. Mayor Marotta explained that the Township's insurance expired on December 31 and reorganziaiton was not until January 1, 2015. Mayor Marotta stated he did not wish to have the Township un-insured for a day.

RESOLUTION #14-206

RESOLUTION OF PARTICIPATION A RESOLUTION APPROVING PARTICIPATION WITH THE STATE OF NEW JERSEY FEDERAL GRANT PROGRAM ADMINISTERED BY THE DIVISION OF CRIMINAL JUSTICE, DEPARTMENT OF LAW AND PUBLIC SAFETY.

WHEREAS, the <u>Vernon Township Police Department</u> wishes to apply for funding of approximately \$60,000 with a match of \$245,452.76 for an approximate project total cost of \$305,452.76 for a project under the State of New Jersey <u>Safe and Secure</u> Grant Program; and

WHEREAS, the <u>Council of the Township of Vernon</u> has reviewed the accompanying application and has approved said request; and

WHEREAS, the project is a joint effort between the Department of Law and Public Safety and the Vernon Township Police Department for the purpose described in the application.

NOW, THEREFORE, BE IT RESOLVED by the <u>Township Council of the Township of Vernon, County of Sussex</u>, State of New Jersey that

- 1. As a matter of public policy the <u>Vernon Township Police Department</u> wishes to participate to the fullest extent possible with the Department of Law and Public Safety.
- 2. The Attorney General will receive funds on behalf of the applicant.
- 3. The Division of Criminal Justice shall be responsible for the receipt and review of the applications for said funds.
- 4. The Division of Criminal Justice shall initiate allocations to each applicant as authorized.

RESOLUTION #14-207

RESOLUTION APPOINTING RISK MANAGEMENT CONSULTANT

NOW, THEREFORE, BE IT RESOLVED by the governing body of "Local Unit", in the County of Sussex and State of New Jersey, as follows:

- 1. The Township of Vernon hereby appoints Skylands Risk Management, Inc./ Wayne F. Dietz as its local Risk Management Consultant.
- 2. The Mayor of the Township of Vernon and Risk Management Consultant are hereby authorized to execute the Risk Management Consultant's Agreement for the year 2015 in the form attached hereto.

AN ORDINANCE AMENDING THE VERNON TOWNSHIP ADMINISTRATIVE CODE CHAPTER 250, ARTICLE II FEES AND ESCROWS ENUMERATED IN SECTION 250-15 RELATING TO ANIMAL CONTROL

Council Member Kadish asked if the late fee was the same in this ordinance as in the previous ordinance. Mayor Marotta explained that it was, but this was a \$3 increase in the cost of the actual license. Mayor Marotta noted the cost of the license had been increased to \$11 several years ago, but even with the

increase the Township was less expensive than half of municipalities. Mayor Marotta noted that the fee would go toward the expansion of the animal control center.
