RESOLUTION AUTHORIZING THE ISSUANCE OF NOT EXCEEDING

\$1,897,996 BOND ANTICIPATION NOTES OF THE TOWNSHIP OF VERNON, IN THE COUNTY OF SUSSEX, NEW JERSEY.

# BE IT RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF VERNON, IN THE COUNTY OF SUSSEX, NEW JERSEY, AS FOLLOWS:

Section 1. Pursuant to a bond ordinance of the Township of Vernon, in the County of Sussex (the "Township") entitled: "Bond ordinance providing for the restructuring of a portion of the cost of acquisition of capacity at the sanitary sewage treatment plant of the Sussex County Municipal Utilities Authority by the Township of Vernon, in the County of Sussex, New Jersey, appropriating \$2,800,000 therefor and authorizing the issuance of \$2,666,000 bonds or notes of the Township for financing such appropriation", finally adopted on November 14, 2011 (#11-23), bond anticipation notes of the Township in a principal amount not exceeding \$1,897,996 shall be issued for the purpose of temporarily financing the improvement or purpose described in Section 3 of said bond ordinance, including (to any extent necessary) the renewal of any bond anticipation notes heretofore issued therefor.

Section 2. All bond anticipation notes (the "notes") issued hereunder shall mature at such times as may be determined by the treasurer, the chief financial officer or the acting chief financial officer of the Township (the "Chief Financial Officer"), provided that no note shall mature later than one year from its date. The notes shall bear interest at such rate or rates and be in such form as may be determined by the Chief Financial Officer and shall be signed and sealed by officials and officers of the Township in any manner permitted by N.J.S.A. §40A:2-25. The Chief Financial Officer shall determine all matters in connection with the notes issued hereunder, and the Chief Financial Officer's signature upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time subject to the provisions of N.J.S.A. §40A:2-8. The Chief Financial Officer is hereby authorized to sell part or all of the notes at not less than par from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price. The Chief Financial Officer is directed to report in writing to the governing body of the Township at the meeting next succeeding the date when any sale or delivery of the notes hereunder is made. Such report must include the principal amount, interest rate and maturities of the notes sold, the price obtained and the name of the purchaser.

Section 3. Any note issued pursuant to this resolution shall be a general obligation of the Township, and the Township's faith and credit are hereby pledged to the punctual payment of the principal of and interest on the notes and, unless otherwise paid or payment provided for, an amount sufficient for such payment shall be inserted in the budget and a tax sufficient to provide for the payment thereof shall be levied and collected.

Section 4. The Chief Financial Officer is hereby authorized and directed to do all other

matters necessary, useful, convenient or desirable to accomplish the delivery of the notes to the purchasers

thereof as promptly as possible, including (i) the preparation, execution and dissemination of a Preliminary

Official Statement and Final Official Statement with respect to the notes, (ii) preparation, distribution and

publication, if necessary, of a Notice of Sale with respect to the notes, (iii) execution of a Continuing

Disclosure Undertaking, with respect to the notes in accordance with Rule 15c2-12 promulgated by the

Securities and Exchange Commission and (iv) execution of an arbitrage and use of proceeds certificate

certifying that, among other things, the Township, to the extent it is empowered and allowed under

applicable law, will do and perform all acts and things necessary or desirable to assure that interest paid

on the notes is not included in gross income under Section 103 of the Internal Revenue Code of 1986, as

amended.

Section 5. All action heretofore taken by Township officials and professionals with

regard to the sale and award of the notes is hereby ratified, confirmed, adopted and approved.

Section 6. This resolution shall take effect immediately.

Jessica Paladini – Vernon Township, spoke to Harry Shortway and any elected and appointed official at the meeting. Ms. Paladini said if you ever publicly lie, slander, harass, or defame her and her reputation and integrity like Harry Shortway did at the last meeting and the last five years, there will be legal

consequences. She feels that Harry Shortway did this because she repeatedly told the Mayor, Council and Business Administrator of the violations to the Open Public Meetings Act, the violations to the Open Public Records Act and the falsified meeting minutes of the Vernon Township High School science teacher and former Environmental Commission Chairwoman Cara Brown and her lawlessness.

Ms. Paladini feels that she was falsely accused of collusion with the MUA over sewer fees. She asked Mr. Shortway why has that building still not been hooked up to the sewer 5 years after he got into office. Ms. Paladini asked if it was because of a deal that was made with the BOE and the current owner to force the Historical Society out.

### **MAYOR COMMENTS**

### PUBLIC MEETING ON CHANGE TO ANNUAL REASSESSMENT

As part of our efforts to Move Vernon Forward, your town government has taken action to:

- 1. Ensure that the property taxes that our residents and other taxpayers are obligated to pay, are accurate, fair, and in line with current market trends; and ...
- 2. Prevent the kinds of sudden and steep property tax changes, or significant "tax shifts", that result from the long, 10-year periods between normal municipal revaluations.

As part of our approach to accomplish these two important objectives, I recently announced that our town had requested, and received, approval from the Sussex County Board of Taxation and the New Jersey Division of Taxation to conduct property reassessments every year, rather than every 10 years.

With the implementation of the process of conducting property reassessments every year, rather than conducting the more costly and bureaucratic property revaluations every 10 years, Vernon Township will join with 116 other New Jersey municipalities who use this method of determining the value of the properties within their borders.

While I have communicated directly, publically, and privately to a host of our residents concerning this change to an annual municipal assessment, the questions that I and our Tax Assessor, Ms. Kristen Umansky, have received reveals to me that my communications have not been as clear or as effective as I had hoped that they would be.

And therefore, on next Monday, September 21, at 7:00 p.m., Ms. Umansky will join with Associated Appraisal Group, the well-known firm that the township has contracted with to assist us in conducting our reassessment program, in hosting a public Zoom meeting presentation and question and answer session on our annual reassessment program.

A notification concerning this public Zoom meeting presentation and question and answer session has already been posted on the town's website; the link that will enable the public to participate in this session will be added to that posting on or before Friday, September 18.

I look forward to the time when important meetings such as this presentation/question and answer session, as well all of our governmental meetings, can again be held in person.

However, at this point in time, the COVID-19 rules concerning the number of individuals that we can have in a facility, combined with the social distance guidelines, do not allow us accommodate residents in our municipal facilities as we did before this coronavirus interceded in our lives.

However, we look forward to you joining the Friday, September 18, Zoom presentation/question and answer session on our town's annual reassessment initiative.

### GOOD NEWS FOR VERNON AND ITS FINANCIAL FUTURE!

My Vernon Family, it is with pleasure I inform you of a result from the Council's and the Mayor's corporative efforts to Move Vernon Forward.

On this past Friday, Moody's Investors Service, the world renowned company that ranks the creditworthiness of borrowers, announced that they had award Vernon Township the bond rating of Aa3, the rating that Moody's awards organizations that are - - and I quote from their rating guide - - "Rated as high quality and very low credit risk".

Based on Moody's judgement of our town's finances prior to 2017, they had put a negative outlook on our town's financial affairs. However, in Moody's press release concerning Vernon's bond rating, they stated, and again I quote, "The negative outlook has been removed".

As reasons for this good bond rating and improved outlook, Moody's cited:

- ¬ Vernon's recent years of rebuilding its Fund Balance - that is the town's savings account - that was started under former Mayor's Shortway's leadership; and the Mayor and Council's wise and appropriate use of funds from that Fund Balance to help out the town's taxpayers in the face of this COVID-19 created economic crisis.
- ¬ The recently implemented plan to replace town vehicles and equipment in an efficient and financially responsible manner.
- ¬ Actions being taken to pay down the town's debt and to create a pay-as-you-go system for most capital expenses.
- Actions being taken to foreclose on vacant lots in Tax Lien status; actions that help to reduce the drain of cash from the town, as well as helping to reduce the amount of tax dollars that we must include in our annual budget as a reserve for uncollected taxes.
- ¬ The recent passage of our Short Term Rental Ordnance, which will not only contribute to making the town safer, but will also bring in income that will reduce tax increases. And...
- ¬ The outstanding support of our town by its largest taxpayer, Mountain Creek. Mountain Creek has not only paid their taxes in full and on time, but they have consistently made their sewer debt payments ahead of time.

These results are indeed good news for Vernon Township and its financial future. And I want to thank our town's Chief Financial Officer, Ms. Donelle Bright, for her very sound and creative financial leadership. Her specific planning, organizing, directing, coordinating, and controlling financial actions played an indispensable role in our town getting this good bond rating, and these very positive financial comments.

I used part of my comments at tonight's Town the Council to shine a light on one of the recent positive things that our outstanding Director of Recreation and Community Affairs, Ms. Mishelle Downtain, and our equally outstanding Senior Center Manager, Ms. Jane Damstra, have done to enhance the quality of life for those senior citizens that we are so fortunate to have as a part of our community family.

As I have previously communicated, we have not yet received approval from the Department of Health to re-open the Senior Center portion of the Municipal Center for the specific purpose of serving our senior citizens.

However, Ms. Downtain and Ms. Jane Damstra have worked close with a host of positive individuals and organizations in our area to put together the procedures and the amenities which allow our seniors to pick up takeout meals at the Senior Center, and offers them the additional opportunity to socialize, from a proper social distance, while eating their meals in a beautiful area under canopy tents located in a safe area out front of the Senior Center.

This beautiful outdoor area for the senior members of our Vernon family was made possible by:

¬ Kuiken Brothers Building Supply Company, who donated the wood that Eagle Scout, Paul Mele, Jr. used to build the planters.

- ¬ Volunteers from the community organization, Vernon Cares, who added a special look to the planters by staining them.
- $\neg$  Ms. Dawn Montanaro, from the McAfee Garden Center, who donated the plants for the planters, and did the planting.
- ¬ Pappas Garden, who donated the plants for all of the other ground containers.
- ¬ Our own Vernon Rotary, who purchased a needed storage shed, locks and solar lights. And in addition, they purchased two complete table and chair sets for this senior facility, provided the human power to build many of the items, and helped with cleaning up the facility and getting it ready for our seniors to use.
- ¬ And of course, our Department of Public Works, which plays such a key role in so many of the things that we do in this township, contributed to this project. Key and indispensable contributions were made by DPW staff members Joe Pariso, Nick Pugliese, Mark Izzo, and Jane Tutolo.

### **COUNCIL COMMENTS**

Council Member Murphy asked if Council President Shortway received the minutes form the last three meetings of the Wastewater Feasibility Committee. She feels the minutes should be completed.

Council Member Murphy asked about the meeting the Mayor and Business Administrator had with residents from Brook Hollow and asked if there was an update.

Mayor Burrell commented that they met with all of the residents from Brook Hollow except one. As an outcome of the meeting they are trying to find financing to build the bridge and they may need an assessment and the residents agreed to this. Mayor Burrell explained that a source to find the financing has not been found. They are still looking for financing and Mayor Burrell asked for ideas if anyone had any ideas as to where Brook Hollow could get the financing from.

Council Member Murphy said she had an idea but did not want to talk about it in public.

Council Member Murphy mentioned that on Route 517 the County painted on the road in large bright letters the word "slow". with an arrow showing that there is a sharp bend coming up. She feels that driving at night this catches your eye and Vernon can use this on some of their roads with sharp turns.

Council Member Murphy commented that she was sorry to see that Cara Brown was subjected to the abuse, and she was sorry to see that she left the Environmental Commission. Council Member Murphy wishes that things like that would stop happening to our very valuable volunteers.

Council Member Auberger thanked the first responders and the public who came out to Vernon's first 911 Memorial Service. It was very nice and great see the different age groups that were there, from the Scouts to the Seniors. He hopes the service happens every year.

Council Member Weller commented that she was not able to be at the 911 Memorial Service but she said she did hear wonderful things about it and it was nice to hear there was such a great turnout.

Council Member Weller told Mayor Burrell that it is wonderful news that Moody's had a good report and thanked him for sharing that new with all of us.

Council Member Weller commented on the trash that was dumped at Maple Grange Park is so disheartening and it is hard to believe that someone would do that to our park. She hopes they find out who did the dumping.

Mayor Burrell responded saying that progress is being made to find out who did the dumping and it is very disheartening.

Council Member Weller commented that the Farmer's Market had over 20 vendors and it was the most amazing Farmer's Market we have had to date. She said it was wonderful to see so many venders and people there and this is what Vernon is all about. Council Member Weller thanked Mishelle Downtain and all the others for all of their hard work.

Council Member Pitsker said he was proud to be at the 911 Memorial and we could not have done it without the Fire Department. He said the Farmer's market had a lot of energy and hopefully in 2 weeks it will be even better.

Council Member Pitsker mentioned that he visited the DPW site with Mayor Burrell and Administrator Voelker where the pump track and trail are being proposed. Council Member Pitsker reviewed the piles of stone, asphalt and railroad ties. He notes that the railroad ties need to be removed because they are construction debris. Council Member Pitsker noted that this area is a worksite for bringing material for various jobs throughout the town. He sees the sites as staging areas and process points to bring material to and determine the proper disposal methods of material. He does believe that the DPW need to be more diligent in keeping with the maintenance and disposal of materials, this will help us address these issues in the future. Council Member Pitsker walked through various areas of the property looking for any issues other than the documented piles that we know about. His findings so far walking through the 11 acres are minimal. He found drainage pipe, various construction material, a couple of tires, and a golf ball. He is a bit perplexed because he had difficulty finding the materials on the site that are pictured on social media but with permission he will continue to hunt for these things in the pictures. Council Member Pitsker said we have an opportunity to clean up what was found and this is our opportunity to fix it and make it right so we can move forward. Council Member Pitsker feels that the DPW's actions needs to be addressed. There needs to be a better process in place, accountability and solutions so that the site is maintained more effectively in the future.

Council Member Pitsker is researching other towns and states who have benefited from the utilization of trails and trail ways. Work needs to be done to confirm the analytics and the cost. Most important safety comes first, as a town we need to address everyone's concerns and do our due diligence to come together to make this happen.

Council Member Pitsker had the opportunity to attend the grand opening of the Executive Insurance. He spoke to some of the business people in the town who either currently have a business in the town or are trying to bring in a business. Council Member Pitsker said that there is a lot of frustration when trying to get permits and work with the Land Use Board to get businesses off the ground quicker. Council Member Pitsker proposes we find a solution, a potential liaison to link the new business prospects to the Township, Government and the building and permitting processes so they can have a better understanding. Council Member Pitsker requested that the Mayor consider to have one of the Committees to address and take action so that we can move Vernon on the business side more effectively.

### COUNCIL PRESIDENT COMMENTS

Council President Shortway commented on the 911 Memorial Service was truly moving and he glad Vernon did it.

Council President Shortway said that Jessi Paladini's accusations are totally false. He thanked Council Member Murphy for sticking up for Cara Brown. He said Cara Brown is a wonderful person who he considers a pillar in this community.

I would like again to point out the Mountain Creek under the leadership of Joe Hession has satisfied all of Creek's sewer financial obligations. This amount is approximately 2.7 million dollars. In addition, MC is current on their property taxes. The Mountain Creek Team not only works with our community they are a vital part of our community.

Currently, Minerals owes Q1-Q3 of their sewer bills for a total of \$133,359.76.

Minerals also owes \$43,191.25 in taxes.

Minerals has also applied for additional building permits and have open permits.

I am respectfully requesting that the Administration enforce our building codes;

341-1: Payment of delinquent taxes and assessments required prior to issuance or reissuance of license or permit.

341-2: Revocation of license or permit for nonpayment; reinstatement.

Our community should not tolerate any entities that do not fulfill their financial obligations and who have a history of controversial action or inaction.

The State has provided the Township a waiver of the requirement to appoint a Municipal Plan Endorsement Advisory Committee.

Mr. Mayor thank you for all of the assistance and leadership by you and your co-workers. We do have some wonderful employees who work for the town and outstanding volunteers and he thanks them all.

### **ADJOURNMENT**

There being no further items of business to be conducted on the agenda, a motion for Adjournment was made by Council Vice President Auberger, seconded by Council Member Murphy with all members voting in favor.
