PUBLIC HEARINGS

LU# 12-24-8 – Danielle Alexander – Block 474, Lot 56, - Variance for a Rear Yard Deck

Danielle Alexander was sworn in to testify for request of variance to construct a rear yard deck. Ms. Alexander explained she purchased the home that has existing sliding glass doors on second level with no deck attached. She added proposed 14' x 16' deck would greatly improve the quality of life for the family, to enjoy lake views, recreational purposes and for pet access to fenced in back yard.

Board Planner Singleton stated application requires a variance for rear yard setback where 25 ft is required in the PLC zone but only 11.5 ft is proposed. He added site building coverage is proposed at 11% where 25% is maximum and lot coverage is proposed at 20% where maximum is 35% which complies with Township Ordinance. Also noted that existing rock wall on property is beyond survey line but as stated by Ms. Alexander was preexisting when purchased.

Ms. Alexander added that the house was built in 2007 with two prior owners and after purchasing site, debris from rear yard was cleaned up and fence installed around rock wall. She added that the proposed deck and stairs will align with existing lower patio walkway.
